PLAYERS PLAYING OUTFIT

PLAYERS OF THE SAME TEAM MUST WEAR THE SAME COLOURS AND REFRAIN FROM WEARING LOGOS FROM OTHER TOURS.

IN THE EVENT THAT BOTH TEAMS ON THE SAME MATCH CHOOSE TO WEAR THE SAME COLOUR, THE HIGHER-RANKING TEAM WILL HAVE THE PREFERENCE AND THE LOWER RANKING TEAM SHALL CHANGE TO ANOTHER COLOUR.

FIP is the legitimate body who makes decisions on any arbitration of a rule or situation not listed or covered by the International Padel Federation rulebook. The decision made is final and without appeal.
