PLAYERS PLAYING OUTFIT

THE TOURNAMENT HAS THE RIGHT TO APPROACH THE PLAYERS FOR A NUMBER OF TOURNAMENT EVENTS /FUNCTIONS, NECESSARY FOR THE PROMOTION OF THE GAME, THE TOUR AND THE EVENT, AS WELL AS EVENT SPONSORS; AS SUCH, PLAYERS MUST MAKE THEMSELVES AVAILABLE FOR THIS ACTIVITIES WHICH SHALL BE REASONABLE IN NUMBER AND SHALL RESPECT THE PLAYER'S TOURNAMENT COMMITMENTS AND RESPONSIBILITIES. PLAYERS ARE STRICTLY AND EXCLUSIVELY COMMITTED TO THE EVENT AND ARE NOT ALLOWED TO PARTICIPATE IN ANY OTHER PRIVATE FUNCTION OR EVEN DURING THEIR PRESENCE IN THE TOURNAMENT CITY, WITHOUT THE WRITTEN CONSENT OF THE ORGANIZATION. VIOLATION OF THIS CLAUSE, MAY RESULT IN THE PLAYER BEING DEFAULT FROM THE EVENT AND/OR FINED BY THE TOUR.

PLAYERS PLAYING OUTFIT

PLAYERS OF THE SAME TEAM MUST WEAR THE SAME COLOURS AND REFRAIN FROM WEARING LOGOS FROM OTHER TOURS.

IN THE EVENT THAT BOTH TEAMS ON THE SAME MATCH CHOOSE TO WEAR THE SAME COLOUR, THE HIGHER-RANKING TEAM WILL HAVE THE PREFERENCE AND THE LOWER RANKING TEAM SHALL CHANGE TO ANOTHER COLOUR.

FIP is the legitimate body who makes decisions on any arbitration of a rule or situation not listed or covered by the International Padel Federation rulebook. The decision made is final and without appeal.
