### Men's category Phase 2

A total of 13 national teams will compete for the 4 places that give access to the Final 8 in a 3-day competition.

1- The teams are divided into 4 Groups, 3 groups with 3 teams each and 1 group with 4 teams.

2- After the Group stage, the best team of each group qualify to Final 8.

3- Teams will be drawn in the following order: Line 1 Group A, Line 1 Group B, Line 1 Group C, Line 1 Group D, Line 2 Group D, Line 2 Group C, Line 2 Group B, Line 2 Group A, Line 3 Group A, Line 3 Group B, Line 3 Group C, Line 3 Group D, Line 4 Group D.

### Seeds 3 and 4 (3. Australia; 4 Iran)

First draw takes line 2 of Group B, remaining one takes line 2 of Group A

### Women's category Phase 2

A total of 10 national teams will compete for the 4 places that give access to the Final 8 in a 3-day competition.

1- The teams are divided into 3 Groups. Two groups with three teams and one group with four teams.

2- After the Group stage, the best team in the groups of 3 teams, and the two best teams in the group of four teams, will qualify for the Final 8.

3. Teams are drawn as per the following order: Line 1 Group A, Line 1 Group B, Line 1 Group C, Line 2 Group C, Line 2 Group B, Line 2 Group A, Line 3 Group A, Line 3 Group B, Line 3 Group C, Line 4 Group C.

### Women's category Final 8

A total of 8 national teams will compete.

1- The teams are divided into 2 Groups with 4 teams each.

2- The best two teams of each group will qualify to semifinals.

### Line 1: Top Seeds (1. Japan; 2. Australia)

Japan takes line 1 in Group A; Australia takes line 1 in Group B

### Seeds 3 and 4 (3. Philippines; 4 Iran)

First drawn takes line 2 of Group B, remaining one takes line 2 of Group A

## REGULATIONS

Deadline to change a team member in case of justified medical injury:

- Phase 2: 15 October
- Final 8: 17 October

### TEAM LINE-UP

The Coach for each Nation must submit the list of the 3 pairs for the tie on each day to the main referee 1 HOUR BEFORE the first game of each tie. A copy of the other team's line up will be exchanged in that moment with the other nation's coach.

Order of play:

- Pair number 3
- Pair number 2
- Pair number 1

Following the submission of team's Line-up and exchange with the other team, no changes in the team line-up will be accepted except in case of an Injury certified by the tournament doctor / physiotherapist before the start of the first match of each tie.

In the event of any player's withdrawal happening during the games, the pair will lose the match by a score of 6-0 / 6-0.

Before each match, the referee will check the names and the passports (each player needs to bring his/her passport / id or a picture of it)

For the scores of a tie to become official and be accounted for, the final score sheets must be signed off by each coach. Failure by any nation's coach to sign off the score sheets will result in that nation losing the tie by 3 – 0.

### PLAYERS PLAYING OUTFIT

Players of the same team must wear the same colors and must refrain from wearing logos from other tours / CONTINENTAL or INTERNATIONAL ASSOCIATIONS.

If both teams in any tie have the same uniform color, the higher-ranked nation will have preference, and the lower ranking team shall change to another color. It is mandatory that each nation has two national kits sets with different colors.

## OTHER INFORMATION

### Medical Coverage

The organization will provide the official tournament doctor and official physios for injury treatment and court injury treatment. No massage service is provided by the organization, and each national delegation is responsible for its own massage services, if required. The organization will provide massage rooms for the use by national delegation's physios / massage therapists, and the booking method will be discussed during the Captains' meeting.

### Accreditations

Each team (male or female) is entitled to request accreditations for a maximum of 8 players, 1 coach, and 1 Federative member.

A maximum of 5 additional team delegation members can be accredited per nation, including physio, additional coach, federative member or guest. Access rights will be based on their operational needs only.

### Visas

Procedure to submit visa requests will be as follows:

- Application to be submitted on [app.qatartennis.org](http://app.qatartennis.org) and please make sure to select the correct tournament name
- Please make sure only a properly scanned passport copy is used; the system will reject incorrect pictures of the passport.
- The passport validity must be at least six month from the event date. The system will reject applications if passport validity is less than six months.
- The person's picture must be a proper passport sized picture with white background. The system will reject selfies.
- Visa requests must be submitted individually, using for each application his/her own email address. The system will reject multiple applications using the same email address.
- Please make sure all information, especially the email address, are entered correctly. The visa, once approved, will be emailed automatically to the email provided in the app during the application process.

## PHASE 2

### ACCOMODATION (at delegation cost)
